

  - iii. To suggest suitable scheme in identified PTG Colonies with Special Central Assistance (SCA) fund.
  - iv. Any other responsibility that may be entrusted by the Government to the Committee from time to time.
  - v. The Committee will function till further notification.
3. This is issued in supersession of all previous notification in this regard.
